#### Reminders!

Please remember to clean up all of your own debris and garbage. Site crew is not to be held responsible. THANK YOU!!!!

Electric-If you are using electric and have not paid for it; your cord will be disconnected and/or cut. Refrigerators and air conditioners are on the list of unapproved items. If you are found to be using these items (or if they are located in your booth) you will loose your electric privileges without refund.

Also, a friendly reminder that we are all "on stage" during the festival. Please limit your cell phone usage and smoking to behind the scenes. Your cooperation is greatly appreciated!

## Overnight Camping

Booth owners (and not just crafts booths)-if you do not have an overnight occupancy permit for your booth, then you are not allowed to sleep there. There will be random checks, especially after participant party, to determine violators. This ordinance is set forth by Scott County and compliance is required. Scott County and the Shakopee Fire Department will be out here to inspect all booths for health and safety issues throughout the season. You could potentially have your pass pulled for this season if you are in violation. This rule applies to all participants, old, new, contracted... whatever. So please take this seriously when making your plans. Approved areas are booths, approved RV's, and the campground. This does not mean you can erect random tents in the campground. You must be approved to sleep there as well. As a side note, there is no siceping in your cars, trucks, tents, screened porches, RV's, trailers etc. in the parking lot. Those found sleeping in unapproved areas will be given a warning by our Security Staff. There are no exceptions to this rule and will be strictly enforced.

The installation is on display in the sculpture Garden of the Walker Art Center, Minneapolis, Mn. until September 27, 2009.

comprised of 47 tuned windchimes, the piece interprets John Cages "Dream", a solo piano work composed fold he Merit Caningham Dance Troupe in 1948. The windchimes are tuned to the notes in the individual measures by the piece, 47 measures
7 windchimes. The random sampling of notes, coupled with the ambient sounds of the city durinding the Sculpture Garden,
reate a perfect realization of the avant garde concepts of Cage's work and the tenets of the current exhibition, "The Quick and
the Dead", which reevaluates the viability of conceptual art in the 21st century.

## Greetings from Safety Services!

Welcome back, and we hope you all have a good season. We have a few things we'd like to go over quickly.

#### Passes

Please make sure you have your pass at all times. Without it, you'll be asked to leave. No one is allowed on site without a pass, no one is allowed through gates without a pass, and no one is allowed after hours without a pass. Please make sure that you and any of your employees have a pass prior to coming to work; those without passes will have to go to B-Gate to obtain them, and will not be allowed to cut through site to get there.

#### Cars on Site

Cars are not allowed to enter site after 8:00a.m, and all cars must be off site by 8:30 a.m.. This has been the rule for well over 16 years. Please do not plan on showing up at 8:45 and expect to be allowed onsite. Also, please note that, at the discretion of MAF management, cars may not be permitted on site if the ground is wet and muddy. If it rains, please plan accordingly.

#### Safety Services / First Aid Hours

Safety Services Staff is on duty from 6:00 p.m. Friday evenings until 2:00 a.m. Monday mornings.

First Aid staff is available from about 8:00 a.m. until 8:00 p.m. If you have a medical emergency after hours that First Aid staff is not available, a member of Safety Services night staff will assist you if possible.

However, Safety Services staff is not under direction from a medical facility and will therefore likely refer you elsewhere for medical attention.

Please refrain from using First Aid as a place to visit and sit and relax.

While the show is open the facility must remain accessible for people needing medical attention. The staff appreciates your visits however they do have a job to do.

Is this the Festival we want?

Thoughts from Carr Hagerman

I wandering the festival on Friday evening, slogging through the dark mud that was q bi-product of a poorly timed but desperately needed rain. It came as no surprise that the site was a muddy as it was and that it would require a lot of grooming to bring it to the point where it was walkable and stable. This site is old and getting worn, and like my own body it seems to take longer to recover from incidents of rain and abuse. But, the site crew did a great job of fixing it, and by the time the festival was underway on Saturday it looked like our festival had been opened for weeks, and the evidence of the mud and rain slowly disappeared.

We've new buildings, one of which is finished (front gate) and looks terrific, while the other, which looks painfully like a saloon, will be finished next year. These buildings are a welcomed sight, giving one the a sense that the festival is here to stay. These buildings aren't inexpensive and they require a lot of deliberate planning and hard work, but the result is they make this place look a little more vital and healthy.

We have a group of new performers that show up each festival morning with smiles on their faces. I've seen them interact with the audience, having fun in the streets, and growing their talents. Inexperienced, certainly, but by the time we get to the final canon they'll be a few of them I believe will emerge as our next generation of star performers.

But with all this hard work to build new buildings and make the grounds look great, and cultivating new performing talent, it only takes one gum chewing employee clad in sunglasses, talking on a cellphone and wearing a modern hat, to put all the efforts to waste. Likewise, with all the hard work some of our performers put into their shows to present clever and quality material, it goes to waste when another show chooses to be genitally focused and salacious.

We are a place full of contradictions, some with more impact than others, but which affect the experience our guests have. I admit that I've been a small part of this problem, knowing that some of my old Rat Catcher routines clearly breached the line of quality and good taste. But as I have spent more time considering the experience from our customers point of view, it seems there is a space for a conversation about what we want to be, as a show. Are we a show that should put an "R" rating in our ads and quit promoting ourselves as a "family" show? What are the limits?

Sunday afternoon, I was watching Twig the Fairy and the way she works with children and families. Watching the parents take pictures, smiling and happy, while their kids dance to Twigs pan pipe, is confirmation of how good it can work when it's done right. A few paces away I can feet level to coming from a stage, while nearby a man is standing on a bench, hawking that, dispatching juvenile/ jokes about breasts and genitals, while families with babies in strollers gates by. Is this the show we believe in? Is this the show our customers want? I can't help but thinking that it's time to consider other options.
